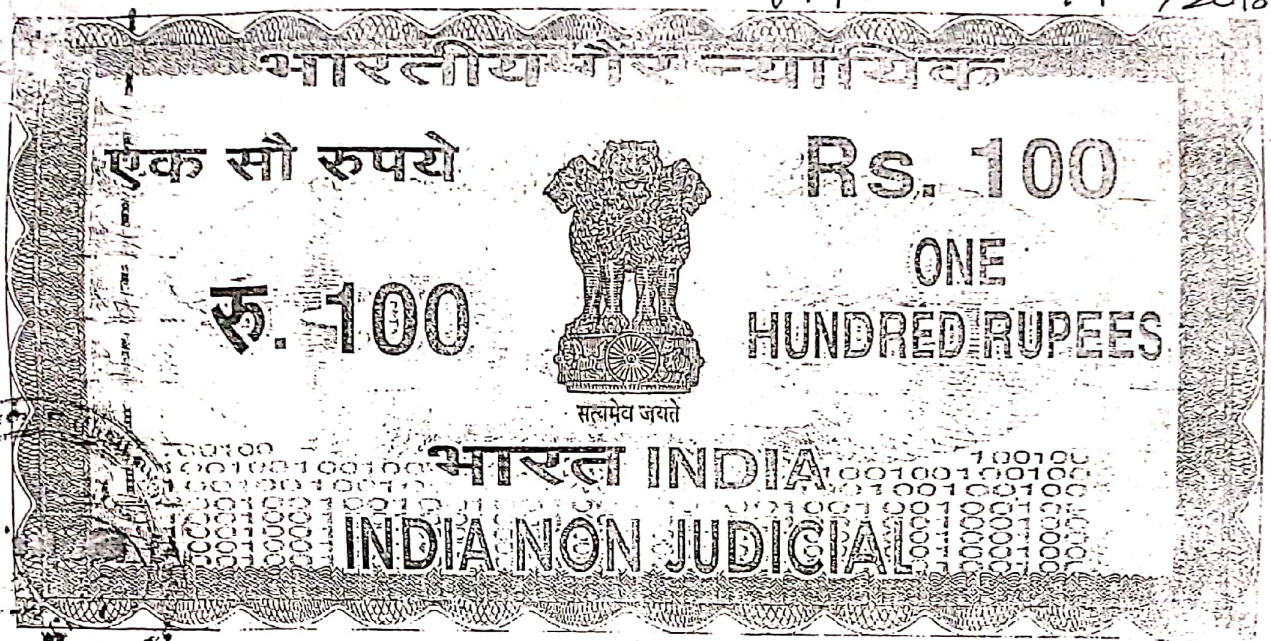

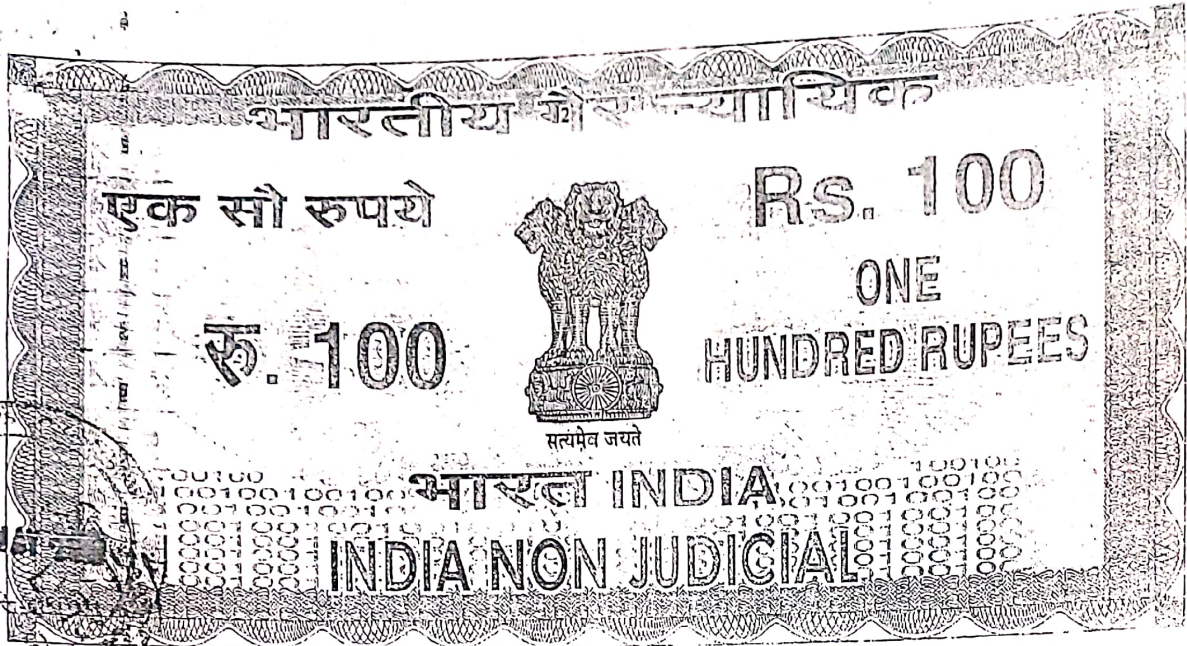

conducive for advancement of any object or objects of general public utility not involving/carrying on any activity for profit.

- q. To help in the preservation of cattle and useful animals.
- r. To publish and or publishing books, pamphlets, periodicals and newspapers in India or outside for the spread and advancement of education and culture.
- s. To act as Trustees of Trust, Managers or Administrators whether solely or jointly with others or another for or in respect of any gift or any property, whether vested in the Trustees of the Trust or otherwise and whether subject to any Trust and notwithstanding that the carrying out of such Trusts, Management and Administration would involve the exercise of the Trust of powers not specifically mentioned in these presents and moreover, to take such steps for the securing of such contributions to the funds of the Trust as may be deemed expedient.

The income and funds of the Trust will be solely utilized towards the objects of the Trust and no portion of the funds will be utilized for payment to the Trustees by way of profit, interest, dividend, etc. However there shall be no bar for payment of remuneration or provision of perquisites to the Trustees for services rendered by them in their professional capacity.
- v. The benefits of the trust are open to all human beings irrespective of caste, community, religion, sex etc.,
4. The above objects shall be independent of each other and the Board of Trustees as herein constituted my from time to time apply the funds of the Trust in carrying out all or any of the aforesaid objects of the Trust as it may deem fit.
5. The Number of Trustees shall in no case be more than eleven and not less than three.
6. The Founder Trustees of the Trust shall be the five persons herein before referred to as Founder Trustees, and shall hold the office as First Trustees for

- life or until they resign from the office of the Trustees. The life trustees are entitled to nominate any one of their family members as their successors who shall hold office for life with similar power of further nomination.
7. All the Founder Trustees who are for the time being, and from time to time, in office, shall be referred to collectively as the Board of Trustees.
 8. The Board of Trustees shall have power and authority to nominate additional Trustees identical to the status of the existing Trustees subject to the provisions of this Deed.
 9. The Trustees so nominated shall hold office for life or until they resign from the office of the Trustees from the date of their appointment as Trustees.

 13. The Board shall have power:
 - a. To engage or remove managers, legal officers, secretaries, accountants, clerks, servants, workmen and other to pay them salaries, wages and gratuities.
 - b. To the same extent as natural persons might or could do, to acquire by purchase, lease, mortgage, loan, gift, grant, legacy company, society, Government or institutions or body whatsoever and to hold all or any part of the movable or immovable properties of all descriptions.
 - c. To alienate by way of sale, mortgage, lease, release Sub-lease loan, charge, hypothecate, pledge, exchange hiring-out, gift or otherwise any or all the properties or funds of the Trust.
 - d. To borrow and to raise funds with security in any manner the Trust may think fit and to repay the same.
 - e. To negotiate with and to enter into arrangements with any authorities of Government whether Central, State, District, Municipal, University, Local or otherwise.

- f. For accomplishment of the objects of the Trust or any of them; and to apply for obtain, collect, receive or recover from any such Government or authority or body such grants, allowances, rights concessions, and privileges, as may seem from time to time desirable and to obtain, carry out, exercise, comply with and utilize the same.
- g. To use all the income from the property, movable and immovable or from the works of the Trust as such, whatsoever derived solely for the advancement of the objects of the Trust.

14. The Board of Trustees shall meet as and when a meeting is:

- a. Convened by the Chairman or at the request of the Chairman by the Secretary and there should be at least two meetings in a year.
- b. At least 10 days' notice shall be given for a meeting and if all the trustees agree they can waive the notice time.
- c. The quorum for a meeting of the Trust shall be two third of the Trustees and the decisions taken by a majority of votes. In case of equality of votes, chairman of the presiding office shall have a casting vote.
- d. The business of the Board shall be transacted with at the meeting of the Board or by Resolution passed in circulations. The paper containing the resolutions so circulated shall be deemed to have been passed if the Trustees signify their consent in the paper.
- e. In addition to regular meeting the Trust shall each year have an annual General Meeting of the members of the Trust, not later than six months from the close of the financial year of the trust.

15. No act of the Board shall be invalid nearly because any vacancy or vacancies in the Board have not been filled in.

16. The Board of Trustees shall elect among themselves, the Chairman, Vice Chairman, Secretary, Joint Secretary and Treasurer for day to day administration and management of the Trust and its institutions.

17. (I) CHAIRMAN:

During the absence of the Secretary, the Joint Secretary will function.

19. TREASURER:

The TREASURER shall have powers and authority for an on behalf of the Board:

- To maintain the accounts of the, Trust and its institution or institutions.
- To operate the Bank accounts along with Chairman and Secretary.
- To read out the accounts in all Board of Trustees meeting and render correct and true account whenever the Boards so requires.
- To carry out the directions of the Board and responsible for the funds of the Trust and its institution.

20. The Term of office of the Chairman and Treasurer shall be for a term of Two years and they will be elected in the Board of Trustees Meeting.

22. No act of the execute officers requiring prevision sanction of the Board shall be invalid merely because such previous sanction was not obtained, provided that such act has subsequently been ratified by the board within three months thereafter. The executive officers shall not perform any act or acts, which is or are detrimental to the Trust or its members. They shall act within the preview of the rules and resolutions of the Trust with utmost care and diligently.

23. The Office year for the purposes of the Trust shall be the financial year 1st April of 31st March and the first year ending will be 31st March.

24. The SECRETARY shall have powers and authority for an on behalf of the Board Shall, not later that the 30th day of June every year, place before the Board for its consideration and adopting the Income and Expenditure account of the previous year ending 31st March and the balance sheet as no that day, together with auditor's Report or certificate thereon, the managing Trustee shall place before the Board all such information and explanation as the Board may require for a proper understanding of the accounts and statements placed before it.




25. The funds and properties of the Trust and every other moneys and properties gifted, conveyed and transferred to the Board of Trustees from time to time for the purpose of carrying out the Trust hereby created and all or any income derived from the Trust.
26. The funds of the Trust shall be invested in the following manner subject to the provisions of sections 11 and 13 of the Income Tax Act:
- In any of the approved securities authorised by Section 20 of the Indian Trust Act, 1882.
 - In the purchase of lands or building or in the construction of the building provided that no such investment shall be made unless with the previous sanction of the Board of Trustees recorded by means of a resolution passed at the meeting of the Board.
 - In current account and/or fixed deposits with any Nationalized Bank approved by the Board of Trustees. By means of Resolution passed by the Majority of the Trustees of the Board and record at the meeting of the Board of Trustees.
 - The income accumulated in any year or years by virtue of section 11(2) of the Income tax Act, 1961 or any amendment thereof shall be invested in accordance with the provisions of that section.
 - The accounts of the Trust shall be maintained regularly and the accounts shall be audited by a Chartered Accountant every year.
 - The Trustees shall maintain proper books of account of the Income and Expenditure of the Trust. The official year for the purpose of the Trust shall be financial year 1st April to 31st March.
 - The activities of the Trust shall not be carried on outside India (i.e) all the charitable activities shall be carried out within India only.
 - The Income accumulated in any year or years by virtue of section 11(2) of the Income Tax Act, 1961 or any amendment thereof shall be invested in accordance with the provisions of that section.
 - The assets/properties of the Trust in the event of dissolution of the Trust will be transferred to a similar Trust with identical aims and objects and registered u/s.12A of the Income Tax Act.



27. The Founder Trustees shall confirm to the provisions of the India Trust Act, 1882 in all matters not expressly provided for herein, but in case any difficulty or doubt arises on any question in respect of the management or administration of the trust or any matters failing hereunder, a per the decision of the Board either the CHAIRMAN or the SECRETARY shall have power and authority for and on behalf the Board may apply to the Court within Walajapet Jurisdictions for opinion, advice, direction or order and the trustees acting upon the direction if such court shall be deemed as far as regards their responsibility to have discharged their duties in respect thereof. 32. 36. A person shall cease to be trustee in any of the following events:

- i) If he dies; or
- ii) If he becomes bankrupt; or
- iii) If he becomes insane or otherwise become incapable to act; or
- iv) If he resigns his office.

37.
